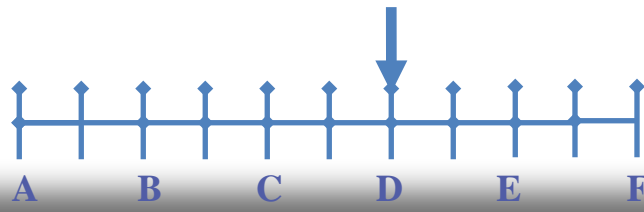

Jefferson Center for Mental Health (Jefferson Center), Jefferson County Public Schools, and the Metro Community Provider Network (MCPN), a local Federally Qualified Health Center (FQHC), work collaboratively on the School-Based Health Center project. The Clinic serves children up to 18 years old and provides immunizations; preventive medical care; substance abuse and violence prevention counseling; asthma treatment; tobacco cessation and prevention programs; acute medical care & behavioral healthcare. Behavioral healthcare services include assessment, focused interventions, wellness and consultation & education.

### Program Type

- Collaboration on-site in an integrated system (mental and primary healthcare provided at a shared facility).
  - Direct Clinical Service; Consultation; Referrals
  - For calendar year 2009 Jefferson Center provided 620 services to 195 students at Alameda High School. (This only reflects recorded contacts in Jefferson Center's database). Numerous other contacts were provided as well.
  - Students receiving services by payor at Alameda High School includes: 60% no payor identified\*, 16% indigent, 16% Medicaid, 5% School Grant. The remaining 3% had primary payors that included CHP+, Social Service funding, private insurance, HB1116 or other BHO Medicaid. (Percentages may exceed 100% due to the student changing primary payor during calendar year 2009 and receiving services under multiple payors).
- \*NOTE:** These students with no payor received at least one service prior to or without becoming an enrolled consumer with Jefferson Center. Jefferson Center does not determine payor for services provided to unenrolled consumers.

### Operational Resources

- Each organization provides the necessary supports to ensure that access to the student's primary or behavioral health records is available and service delivery is seamless.
- Each entity is responsible for the supervision, technical resources and operational supplies to support the healthcare delivered by its staff.
- Behavioral health charting is done in Jefferson Center's EMR.

### Fiscal Resources

- Funding for this School-Based Health Center is provided through grants, the school district and MCPN.
- Students are seen regardless of ability to pay and county of residence. Students are not billed for services.
