EXECUTIVE SUMMARY

Rocky Mountain HealthNet represents mental healthcare providers in Colorado who are members of the Colorado Behavioral Healthcare Council. This extensive alliance was formed for the purpose of responding to the FCC Pilot Program in an effort to gain access to telemedicine services through a new broadband regional network.

CBHC is a non-profit 501 (c) 3 membership organization that represents Colorado's statewide network of community mental health centers. Providers include 17 community mental health centers (MHCs), two specialty clinics, and five behavioral health organizations (BHOs). CHBC member organizations contract with the State of Colorado and work together to provide comprehensive behavioral and psychiatric services to defined geographic areas of the state. The consortium is comprised of 181 eligible (e.g., either public or non-profit) healthcare provider sites, of which 72 (40 percent) are rural.

Our application will create a regional broadband healthcare network throughout the state of Colorado.

Our proposed network design will provide consortium members with an infrastructure that can be used to transmit voice, data and video among one another, with other healthcare providers, and access the public Internet and Internet2. The design also provides access to information service providers that can deliver services on one network. Upon award, we will issue a request for services for a wide-area Ethernet network that provides access to each of the participating healthcare facilities.

We request \$5,064,300 in USAC support over a three-year period, at \$1,688,100 per year. This funding will be matched by a minimum of 15 percent from our members financed primarily through substitution for their current network budget for the proposed network. For-profit entities sharing our network will pay their full costs. Participating facilities span all counties of Colorado. Recurring charges, including Internet and Internet2 service, are estimated to cost approximately \$685/month per site on average, with \$580 subsidized by the USAC Pilot Program, and an end-user match of approximately \$105/month.

The applicant organization, the Colorado Behavioral Healthcare Council, will provide project management for the proposed effort. Principal responsibility will lie with the Executive Director of CBHC. Oversight will be provided by the CBHC board.

CBHC, as fiscal agent and institutional home for Rocky Mountain HealthNet will comply with and fulfill the requirements of FCC Orders 06-144 and 07-198 and all applicable regulations of the FCC, USAC, and RHC in building and operating the proposed network including filing Forms 465 and 466 for all members.

CBHC will hire or share with a sister Pilot Program participant the services of a FCC Pilot Project Director. No federal USAC funds will be used for this purpose. Program coordination staffing and activities will be carried out using internal CBHC resources. Program coordination will include the leadership, fund-raising, and implementation needed to develop healthcare applications enabled by the proposed network.

After the completion of this Pilot Program, all ongoing monthly costs outlined in this proposal are eligible for funding under the current rules of the USAC – RHCD program for all rural healthcare participants. Net costs for services to the rural health provider will be the comparable urban rates. This network is to be self-sustained through the USAC Rural Health Care Funding Mechanism, either current rules or new rules stemming for the success of the Pilot Program. Non-eligible and for-profit Members will pay their full share of network costs.

1. LEGAL AND FINANCIAL RESPONSIBILITY

The Colorado Behavioral Healthcare Council (CHBC) is the applicant organization and will bear full legal and financial responsibility for the proposed project.

CBHC is a non-profit 501 (c) 3 membership organization that represents Colorado's statewide network of community mental health centers. Providers include 17 community mental health centers (MHCs), two specialty clinics, and five behavioral health organizations (BHOs). The consortium is comprised of 181 eligible (e.g., either public or non-profit) healthcare providers sites, of which 72 (40 percent) are rural.

CBHC member organizations contract with the State of Colorado and work together to provide comprehensive behavioral and psychiatric services to defined geographic areas of the state.

CBHC provides a network of skilled therapeutic and community resources to meet the mental health need of all Colorado residents and their families so that all can have equal and full access to a quality of life. Throughout Colorado, thousands of individuals once isolated and disabled by mental illness, are now leading productive, satisfying lives.

2. GOALS AND OBJECTIVES

Research has confirmed that the FCC's Rural Heath Care program, funded through the Universal Service Fund, is significantly underutilized by rural health care providers. The goals of the Pilot Program and the objectives of our application are to provide funding to support the construction of regional broadband networks and information services associated with those networks.

There are a number of factors that may explain the underutilization of this important fund. As stated in the Pilot Program Order, there continues to be a lack of broadband access facilities. However we do not believe that the primary reason for underutilization of funds is the lack of broadband access in rural America.

Private telecommunications services are available in virtually every jurisdiction in the United States. Observations over the past 8+ years have rarely shown infrastructure facility problems interfering with implementation of a service such as a T1 in rural America. We recognize that there will be a need to upgrade infrastructure to increase bandwidth beyond T1 speeds. However, rural America has yet to catch up with the IT technical skills needed to support medical services that may rely on these higher speeds.

This fact supports the relevance and importance of our proposal. It is our goal to deploy a network using advanced technology that will improve the existing infrastructure of rural Colorado. With nominal funding, we believe that our proposal can have a significant impact on our ability to provide and support the medical services that need to be deployed today. This accomplishes two objectives. Many rural healthcare providers will quickly be connected to world-class information and image management capabilities and will be poised to take advantage of leading edge technology that otherwise would take years to access. We believe that this is consistent with the FCC's pilot program's objectives

It is most likely the FCC's effort to address the underutilization of this fund by implementing a pilot program has significantly increased awareness of the Rural Health Care Support Mechanism. As important as it is to make the funding process administratively easier for rural health care providers, the heightened awareness and the possible expansion of the list of services available for funding will result in a significant increase of fund utilization.

Because of the significant number of members included in the Rocky Mountain HealthNet, we believe that this proposal provides excellent value to the funding mechanism. There is extensive participation by rural health care providers that will aggregate their specific service needs while leveraging existing technology to adopt the most efficient, effective and cost-conserving means.

Healthcare providers in the state of Colorado have historically underutilized the Rural Health Care Support Mechanism. In FY2005 a total of 30 healthcare providers from Colorado filed Form 465s. Most importantly, of those 30 healthcare providers only 15 have been funded. The numbers for FY2006 reflect a further reduction in participation with only 18 filings.

We believe that the true measure of success will be a higher level of participation in the RHC program and not the amount funded. Additionally, this participation must quickly provide world-class medical management tools in order to make the health care providers more effective. We have a large number of public and non-profit healthcare providers participating in this proposal with a significant representation from rural Colorado.

HISTORICAL USE OF THE RURAL HEALTH CARE SUPPORT MECHANISM

If this proposal is accepted, it would be the first time any of the rural members of this consortium would receive FCC funding. This consortium represents a significant increase in funding requests from the state of Colorado.

We are requesting support under the Pilot Program for several reasons. First, individually we do not have the financial resources and personnel to provide the FCC with this business proposal on our own. We have chosen to combine our resources in an effort to not only take advantage of this funding for telecommunications services, advanced telecommunications services and information services under the Pilot Program. Pilot Program participation will provide an incentive for group purchasing—outside the scope of federal USAC support—of information services such as interactive video, picture archival communications systems (PACS), electronic health records, healthcare administrative systems, psychiatry and many others.

Through our network, we as a group have the opportunity to gain access to services at a lower cost than if we were to purchase them individually. For example; we can deploy an electronic health records system (information service) over this network through an array of providers. Electronic health records companies will spread the cost among the consortium members. The services provided over this system will enhance the accessibility to mental health services that are often not available in rural and sparsely populated areas. We believe that this aligns our goals with the President's EHR initiative.

The regional network we propose will obtain services from eligible telecommunications service providers in accordance with and in compliance with the processes established by the USAC/RHC Pilot Program.

INTERNET2

This proposal takes advantage of the opportunity to gain access to Internet2. Connection to Internet2 (and/or National LambdaRail) will provide consortium members to opportunity to rapidly access relevant clinical resources and innovative applications available being developed at research universities throughout the country.

NETWORK DESIGN

The network will be a truly a "healthcare" network dedicated to healthcare providers and the entities that provide support services. It will be a private secure network that meets all HIPAA compliance requirements for transmitting voice, data and video from one participant to another.

Some of the consortium members have minimal Internet or telecommunications services in place today. Many different telecommunications technologies are applied in these networks. VPN technology over the Internet commonly is used because of lower cost. However VPNs do not offer the quality of service necessary to handle the significant bandwidth requirements of many of the applications such as telepsychiatry, clinical assessment, provision of specialty mental health services, staff training, culturally relevant services, and electronic health records. VPN technology also places an additional network support burden on the healthcare provider's IT administrator. Other technologies such as frame relay, ATM, MPLS, private lines and others provide the needed quality of service, yet have cost considerations that must be taken into account by the rural healthcare provider.

Our proposed network design will provide consortium members with an infrastructure that can be used to transmit voice, data and video among one another, with other health care providers, and access the public Internet and Internet2. The design also allows access to information service providers that can deliver services on one network.

Upon award, we will issue a request for services for a wide-area Ethernet network that provides access to each of the participating healthcare facilities listed in Appendix 1. Information technology expertise is scarce throughout rural America. Ethernet technology provides an ease of management. Most small rural health care locations do not have the resources to support the technology needed to deploy many of the needed medical services. Typical workstation problems translate into a very significant administration problem in rural America. The fact that there are great distances between sites exacerbates an already difficult support issue. By deploying Ethernet, healthcare providers can more easily take advantage of advanced services with minimal telecommunications expertise.

3. ESTIMATED NETWORK COSTS

The service requested is wide area Ethernet service, at 1.5 Mbps per site minimum. The project will serve 50 percent of our facilities by the end of Year 1, 75 percent by the end of Year 2 and 100 percent by the end of Year 3. The project will complete all non-recurring installation costs in Years 1 and 2. Non-recurring charges include installation and routers. The average per facility non-recurring cost is estimated to be approximately \$7,500. From Year 3 onward, project costs will be stable. Recurring charges, including Internet and Internet2 service, are estimated to cost approximately \$685/month per site on average, with \$580 subsidized by the USAC Pilot Program and an end-user match of approximately \$105/month.

4. FAIR-SHARE PAYMENTS BY FOR-PROFIT ENTITIES


If non-eligible (e.g., BHOs) or for-profit entities are allowed to join the Rocky Mountain HealthNet, they will be invoiced separately for each service item for their fair share of the network costs without USAC subsidy. These invoices will be provided directly to the for-profit participant. USAC will receive invoice documentation that reflects eligible rural health care providers only. No non-eligible or for-profit sites have been included in Appendix 1.

5. SUPPORT FOR COSTS NOT COVERED BY THE FUND

All participants have some type of access to the Internet or private telecommunications services today. The costs for the rural participants can be quite high for the nominal service they currently receive. The costs for services outlined in this proposal will be replacing those existing services and each participant will provide funding under their general operating budget for the approximately 15 percent of remaining costs.

6. PARTICIPATING FACILITIES

CBHC sites eligible for USAC support, and only those sites that are eligible, are listed in Appendix 1. These include Mental Health Centers (qualifying as such under federal definition) and Mental Health Clinics. The geographical dispersion of these facilities is statewide, as illustrated in the map below.



7. PREVIOUS EXPERIENCE IN DEVELOPING AND MANAGING TELEMEDICINE PROGRAMS

Currently many members of Rocky Mountain HealthNet are managing private telemedicine networks. Virtually all of the represented mental health facilities have been using interactive video in their practices for a number of years. However, this and other telehealth technologies have more room grow. By having this network in place, the healthcare providers will be able to more easily negotiate or form partnerships with other HealthNet healthcare providers. Through the proposed network development effort, the complexity of building an infrastructure will be overcome and the healthcare provider can focus on their core mission.

8. PROJECT MANAGEMENT PLAN

PROJECT LEADERSHIP

The applicant organization, the Colorado Behavioral Healthcare Council, will provide project management for the proposed effort. Principal responsibility will lie with the Executive Director of CBHC. Oversight will be provided by the CBHC board.

MANAGEMENT STRUCTURE AND WORK PLAN

CBHC, as fiscal agent and institutional home for Rocky Mountain HealthNet, will comply with and fulfill the requirements of FCC Orders 06-144 and 07-198 and all applicable regulations of the FCC, USAC, and RHC in building and operating the proposed network. CBHC will hire or share with a sister Pilot Program participant the services of a FCC Pilot Project Director.

As per this Revised Application, CBHC will proceed to follow the prescribed process in the FCC Orders. Namely, we will obtain Letters of Agency from each of our participants, complete and file Form 465, select a service provider, file Form 466, obtain funding authorization, file Form 467 as services contracts are established, file the quarterly reports required by Order 07-198, maintain all audit records as required and cooperate with all audit requests.

will be carried out using internal CBHC resources. Program coordination will include the leadership, fundraising, and implementation needed to develop healthcare applications enabled by the proposed network.

10. SUSTAINABILITY

After the completion of this Pilot Program, all ongoing monthly costs outlined in this proposal are eligible for funding under the current rules of the USAC – RHCD program for all rural healthcare participants. Net costs for services to the rural health provider will be the comparable urban rates. This network is to be self-sustained through the USAC Rural Health Care Funding Mechanism, either current rules or new rules stemming for the success of the Pilot Program. Non-eligible and for-profit members will continue to pay their full share of network costs.
