Business Topics: Telehealth, Technology, Cybersecurity, Data Collection, Current Business Practices, Accounting, Innovative Programs, AI

Social Determinants: Public Health, Human Services, Law Enforcement/First Responder Issues, Social Exclusion, Urbanization, Food Insecurity, Housing, Diversity, Equity, and Inclusion

Proposal Timetable:

Timely submission is critical to inclusion in the program. The procedures and timetable enumerated below will apply.

- Deadline for Proposals
 All session proposals must be submitted by 11:59 pm on April 15, 2025. However, you are
 encouraged to submit a proposal ahead of time.
- Acceptance of Proposals
 You will be notified by May 1, 2025 if your session has been selected. The number of accepted
 proposals is limited to the current available sessions. The Committee will contact the author of each
 proposal.

Submission Guidelines:

Session proposals should be prepared in accordance with the formatting section below. Please use **THIS ONLINE FORM** to fill out the below information.

If you have any issues using the online form, you may download and fill out this <u>WORD FORM</u> and email it to Brittany Langevin at <u>blangevin@cbhc.org</u>.

All submissions should include the following:

- Name, email address, phone number, and physical mailing address of the presenter
- <u>Up to</u> a 50-word bio of the presenter
- Presenter's CV/Resume
- Proposed session title
- 50-word session abstract/description
- Length of session (45 minutes, 60 minutes, 90 minutes, 2 90-minute session)
- Full description of proposed session (with outline or power point if available)
- Include outcome and learning objectives for the session attendees
- Describe your presentation style and the format of this specific session
- Requested compensation, if applicable (including honorarium, travel reimbursement & hotel accommodations) *

Though a video or audio recording of the presenters is not required, it is highly recommended in order to help the selection committee appreciate the skills and style of the presenter.

Please note that the description of your session is what is expected to be presented at the conference. If your session is selected and you determine that changes should be made to your initial submission, you must submit those changes in writing to Brittany Langevin at blangevin@cbhc.org as soon as possible. The Planning Committee will then review those changes and determine whether or not to move forward with your session. This ultimately allows CBHC and the Conference Planning Committee to be informed of final presentation details as needed.
